# Overview

INVITATION TO PRE-QUALIFICATION AND TENDER (TECHNICAL AND FINANCIAL) FOR YEARS 2016-2019 (MERGED) TETFUND PROJECT MAINTENANCE INTERVENTION 2019R/SX51 ENUGU STATE UNIVERSITY OF SCIENCE AND TECHNOLOGY (ESUT) P.M.B. 01660, AGBANI, ENUGU STATE, NIGERIA

### (1.0) BACKGROUND

- (1.1) The Enugu State University of Science and Technology (ESUT), Agbani. Enugu State is a beneficiary of the Years 2016-2019 (Merged) Tertiary Education Trust Fund Project Maintenance Intervention 2019R/SX51.
- (1.2) Accordingly, and in line with the provisions of the Public Procurement Act 2007, the University hereby invites interested and reputable Contractors with relevant experience and track record to submit Technical and Financial Bids for the project below

## (2.0) SCOPE OF WORKS

2	Additional Project: Supply and Installation of 2Nr 6 -in-one Lecture Hall wooden Seats.

### (3.0) COLLECTION OF TENDER DOCUMENTS

Interested companies are to collect the Standard Bidding Document (SBD) for above project from the office of the Director. Physical Panning Unit (DPPU), Enugu State University of Science and Technology, Agbani, from 8am to 4pm each day, Monday to Friday upon presentation of evidence of payment (receipt) issued by the Bursary Department of a non-refundable tender fee of Ten Thousand Naira (N10,000.00) only per Lot.

#### (4.0) SUBMISSION OF TENDER DOCUMENTS

Prospective bidders are to submit bid for the Lots; two (2) hard copies each of the technical and financial bids, packaged separately in sealed envelopes and clearly marked as "Technical Bid' or "Financial Bid'. Thereafter, put the two sealed envelopes together in a bigger sealed envelope addressed to The Registrar, Enugu State University of Science and Technology (ESUT), Agbani, and clearly marked YEAR 2016-2019 (MERGED) TETFUND PROJECT MAINTENANCE INTERVENTION 2019R/SX51 with the lot number and lot description. Furthermore, the reverse of each sealed envelope should have the name and address of the bidder and dropped in the designated Tender box at the Office of the Registrar, **not later than 12:00 noon on Monday, 24 May, 2021.** 

#### (5.0) OPENING OF BID

The technical bids will be opened immediately after above set deadline for submission at 12:00 noon on Monday, 24 May, 2021 in the Council Chamber in the Administrative Building of the Enugu State University of Science and Technology (ESUT), Agbani, while the financial bids will be kept un-opened.

#### (6.0) GENERAL INFORMATION

- (a) Bids must be in English Language and signed by an authorized official
- (b) Bids submitted after the deadline for submission will be returned
- (c) All costs will be borne by the bidders
- (d) Only pre-qualified bidders will be contacted at a later date for financial bid opening, while bids of unsuccessful bidders will be returned unopened;

- (e) All cost incurred as a result of this tender invitation and subsequent request for information shall be borne by the bidding companies and only short-listed companies will be contacted;
- (f) Presence of bidders/representatives and members of the public shall not be required during the bid opening ceremony in compliance with COVID-19 Guidelines. The Bids opening will be covered by video recording with the presence of two (2) representatives of private sector professional bodies and civil society organization in the areas of Anti-Corruption/Transparency;
- (g) Bid documents can also be collected in soft copies and Bidders can submit through Post (Courier Services);
- (h) The University is not bound to prequalify any bidder and reserves the right to annul the procurement process at any time without incurring any liabilities in accordance with Section 28 of the Public Procurement Act 2007.

#### (7.0) ELIGIBILITY REQUIREMENTS

(Below are the minimum qualifications bidders must meet):

- (a) Evidence of Certificate of Incorporation issued by Corporate Affairs Commission (CAC) including Form CAC1.1 or CAC2 and CAC7;
- (b) Evidence of Company's Income Tax Clearance Certificate for the last three (3) years valid till 31st December, 2021, with minimum average annual turnover of N 100,000.000.00;
- (c) Evidence of current Pension Clearance Certificate valid till 31st December, 2021;
- (d) Evidence of current Industrial Training Fund (ITF) Compliance Certificate valid till 31st December, 2021;
- (e) Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Clearance Certificate valid till 31st December. 2021;

- (f) Evidence of registration on National Database of Federal Contractors. Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring 31st December. 2021 or valid Certificate issued by Bureau of Public Procurement (BPP);
- (g) Sworn Affidavit disclosing whether or not any officer of the relevant committees of the Enugu State University of Science and Technology or the Bureau of Public Procurement is a former or present director or shareholder or has pecuniary interest in the bidder and to confirm that all information presented in the bid are true and correct in all particulars;
- (h) Company's audited accounts for the last three (3) years (2018, 2019 and 2020);
- (i) Evidence of financial capability to execute the project by submission of Reference Letter from a reputable commercial bank in Nigeria, indicating willingness to provide credit when needed;
- (j) Company's Profile with curriculum Vitae of Key Staff to be deployed to the project, including copies of their Academic/Professional qualifications such as COREN, QSRBN, ARCON, CORBON, etc.);
- (k) Verifiable documentary evidence of at least three (3) similar jobs executed in the last five (5) years including Letters of Awards, Valuation Certificates. Job Completion Certificates and Photographs of the projects;
- (I) List of Plants/Equipment with proof of Ownership/Lease;
- (m) All documents for submission must be transmitted with a covering letter under the Company/Firm's Letterhead paper bearing amongst others, the Registration number (RC) as issued by CAC, Contact Address, Telephone Numbers (preferably GSM No ), and e-mail address. The Letterhead Paper must bear the Names and Nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorized officer of the firm.
