(iii.) Evidence of registration on the National Database of Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 01 /01 2018 or Valid Certificate issued by BPP.

(iv.) However the requirement for Certificate of Registration for VAT, and evidence of remittances for the past three (3) years is hereby expunged as Tax clearance certificate for three years covers for them.

(3.) Submission of Tender Documents: The new closing date for submission of bids is now **Tuesday, 26th September, 2017 by 12.00 noon**. Opening of Tender Documents will hold immediately.

Tenders shall be subjected to strict technical evaluation. Interested contractors/companies are required to submit the following pre-qualification documents in sequential order:

- (a) Certificate of Incorporation/Registration with Corporate Affairs Commission (CAC).
- (b) Tax Clearance Certificate for three (3) years expiring on 31st December, 2017.
- (c) Certificate of Registration for VAT, and evidence of remittances for the past three (3) years.
- (d) Audited Accounts for the last three (3) years i.e 2014, 2015 and 2016.
- (e) Company Profile which should include (i) Names of current Directors as registered with CAC (ii) Names, Qualification and Experience of key Personnel.
- ((f) Evidence of similar projects executed with job completion certificates.
- (g) Evidence of registration on the National Database of Contractors, Consultants and Service Providers.

(h) Evidence of Financial capability/ Bank Reference and Statement of Account for the last 12 months.

(i) Certificate of compliance with Pension Reforms Act, 2004, issued by the Pensions Commission.

(j) Certificate of compliance with Training Contribution to ITF.
