(1) Evidence of Registration with the Corporate Affairs Commission (CAC) with the inclusion of Certificate of Incorporation and Articles of Association.

(2) Last 3 years (2016, 2017& 2018) Company Tax Clearance Certificate.

(3) Possession of experience as a Prime Contractor in at least (2) projects of similar nature and complexity with verifiable letters of contract award and certificates of job completion within the last Five (5) years.

(4) Detailed Company profile and Organisation structure including names and telephone numbers of key personnel (Technical/Managerial).

(5) Evidence of financial capability (Reference letter from reputable bank).

(6) Copies of VAT Registration with TIN number and evidences of VAT remittances for the last 3years.

(7) Company's Audited Accounts for the last three years.

(8) Evidence of 3 years development levy for two directors.

(9) Evidence of registration as a Contractor with the Lagos State Government as Works Contractor in any of CLASS F to J.

(ii) All claims must be adequately substantiated with documents and must be verifiable.

(iii) The Lagos State Ministry of Education shall deal directly with only the authorized officers of interested companies and not with their agents.
