(ii) Evidence of Company's Income Tax Clearance Certificate (or Personal Income Tax Clearance Certificate of all Partner, where applicable) for the last three (3) years valid till 31st December, 2020 (where applicable)

(iii) Evidence of current Pension Compliance Certificate valid till 31st December, 2020 (where applicable)

(iv) Evidence of current Industrial Training Fund Compliance Certificate valid till 31st December, 2020 (where applicable).

(v) Evidence of current Nigeria Social Insurance Trust Fund NSITF) Compliance Certificate valid till 31st December 2020.

(vi) Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring 30/06/2020 0rvalid certificate issued by BPP.

(vii) Sworn Affidavit disclosing whether or not any officer of the relevant committee of the Federal school of Medical laboratory Technology (Science), Jos or the bureau of Public Procurement is a former or present Director shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars.

(ix) Evidence of financial capability to execute the project by submission of Reference Letter from areputable commercial bank in Nigeria, indicating willingness to provide credit facility for the execution of the project when needed.
