## (1) INTRODUCTION

(b) Evidence of Firm's Tax Clearance Certificate (or Personal Income Tax Clearance Certificate of all the Partners) for the last three (3) years valid till 31<sup>st</sup> December, 2019;

(c) Evidence of current Pension Compliance Certificate valid till 31st December, 2019 (where applicable);

(d) Evidence of current Industrial Training Fund (ITF) Compliance Certificate valid till 31<sup>st</sup> December, 2019 (where applicable);

(e) Evidence of current Nigeria Social Insurance Trust Fund (NSITF) compliance Certificates valid till 31<sup>st</sup> December, 2019;

(f) Evidence of Registration on the National Database of Federal Contractors, Consultants, and Services providers by submission of Interim Registration Report (IRR) expiring on 31<sup>st</sup> January, 2020 or valid Certificate issued by BPP;

(g) Sworn affidavit disclosing whether or not any officer of the relevant committees of Modibbo Adama University of Technology, Yola or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particular.

(h) Company's Audited Accounts for the last three (3) years (2016, 2017, 2018);

(i) Evidence of financial capability to execute the project by submission of Reference Letter from a reputable Commercial Bank in Nigeria indicating willingness to provide credit facility for the execution of the project when needed;

(j) Company profile with the Curriculum Vitae of Key staff to be deployed for the project, including copies of their Academic/Professional qualifications;

(k) Verifiable documentary evidence of at least three (3) similar Jobs executed in the last five (5) years including Letters of Awards, Valuation certificate, job completion certificates and photographs of the projects;

(I) Evidence of firm's registration with Computer Professionals Registration Council of Nigeria (CPN) and National Information Technology Development Agency (NITDA);

(m) Lot 2: Evidence of accreditation by Centre for Management Development;

(n) For Joint Venture/Partnership, Memorandum of Understanding (MoU) should be provided (CAC, Tax Clearance Certificate, Pension compliance, ITF Compliance Certificate, NSITF Compliance Certificate, IRR & Sworn Affidavit are compulsory for each JV partner).

(o) All documents for submission must be transmitted with a Covering/Forwarding letter under the company/Firms Letter head paper bearing amongst others, the Registration Number (RC) as issued by the Corporate Affairs Commission (CAC), Contact Address, Telephone number (preferably GSM No.) and e-mail address. The Letter head paper must bear the Names and Nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorized officer of the firm.

Interested firms are to submit two (2) bound of Expression of Interest (EoI) document separated by dividers and arranged as indicated above. Furthermore, the reverse of each sealed envelope should bear the name and address of the bidder and drop in the
