A. INTRODUCTION

D. PRE-QUALIFICATION REQUIREMENTS

- (c.) Certificate of National Pension Commission Registration/ remittances in compliance with the provision of the Pension reform Act, 2004.
- (d.) Certificate of compliance with the Industrial Training Fund Amendment Act 2011, by inclusion of compliance letter from the Industrial Training Fund.
- (e.) Evidence of registration on the National Database of Contractors, Consultants and Services Providers by inclusion of Interim Registration Report (IRR) from BPP
- (f.) Evidence of registration with professional bodies such as ARCON, COREN, SURCON etc. by inclusion of Certificate of Registration.
- (g.) Company Profile; including Curriculum Vitae and details of professional registration of the personnel with genuine reachable addresses and phone numbers (enclose photocopies of credentials).
- (h.) Verifiable evidence of previous experiences in handling similar projects, including list of projects, names of clients, contract values, letters of award.
- (i.) Evidence of technology and equipment whether owned or lease and serviceability. (j.) Reference/ guarantee letter from a reputable bank.
- (k.) Company Audited Account for the last three (3) years (i.e. 2014, 2015 and 2016).
- (l.) A sworn affidavit certifying that:
- (i.) All the required documents submitted are both GENUINE and UP-TO-DATE
- (ii.) None of the Directors of the Company has ever been convicted by any Court of Law
- (iii.) None of the Directors of the Company is a staff of the Federal Polytechnic, Offa
- (iv.) The Company is not bankrupt or a party to liquidation proceedings in any Court of Law Kindly note that items (a) (h) in the above criteria are MANDATORY and failure to produce any will lead to automatic disqualification of the Company.
