ELIGIBILITY REQUIREMENT

Prospective bidders are required to submit a comprehensive expression of interest document that highlights the bidding company/firms' ability to carry out the service. The expression of interest documents must contain the following:

(1) Company Data: (for Joint Venture or Consortium, provide data for the lead firm)

- (2) Evidence of Registration with Corporate Affairs Commission, namely Certificate of Incorporation, Memoranda & Articles of Association, form CAC7, CAC2 and CAC/BN/A1 (Certify True Copy)
- (3) Evidence of Tax Clearance Certificate (or Personal Income Tax Clearance Certificate of all the Partners) for the last three years i.e. 2017, 2018, and 2019 expiring on 31st December, 2020;
- (4) Evidence of Pension Clearance Certificate for three years i.e. 2017, 2018, and 2019 expiring on 31st December, 2020 where applicable.
- (5) Evidence of current Industrial Training Fund (ITF) Compliance Certificate expiring on 31st December, 2020
- (6) Evidence of Nigeria Social Insurance Trust Fund (NSITF) compliance certificate valid till 31st December 2020
- (7) Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 30/06/2020 or valid Certificate issued by BPP
- (8) The companies/firms must provide a copy of its license authorizing it to practice as issued by the relevant professional regulatory bodies
- (9) Sworn Affidavit:

that the company/firm is not in receivership/bankruptcy

that none of the directors or partners of the company/firm is an ex-convict in any country for any criminal offence relating to fraud or financial impropriety

disclosing whether or not any officer of the relevant committees of the National Agency For Food And Drug Administration And Control or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars;

- (10) Detailed Company/firms profile, indicating Management structure, size, strength and numbers of Management, Technical & None Technical Staff, including Names, qualifications and years of experience, photocopies of qualifications from relevant professional bodies must be attached
- (11) Verifiable evidences of at least three experience in similar assignment of comparable complexity (Tabulated) with details comprising of Client Name, Brief description of Project, Project location, Contract Value, Implementation role, the status of Project as completed or on-going, in addition, evidence of award letters, or commission letters, Payment Certificate (if on-going) and Completion Certificate from clients as Tabulated must be shown.
- (12) Evidence of technical resources and equipment to execute the assignment (Computer software with proof of acquisition or renewal of license from original software developers) Computer hardware etc.
- (13) Evidence of financial capability with proof of access to funding or a letter from a Commercial bank with an assurance of willingness to provide a facility to the prospective consulting firm if the company/firm turn-out to be successful. Please note that Banker's letter merely stating that the applicant is a customer or maintains an account with the bank without commitment is not acceptable.
- (14) Evidence of Audited Financial Statement for the last three years i.e. 2017, 2018 & 2019 stamp and sign by client Auditor. (Turnover, as reflected in Financial Statements, must correspond with that on the Tax clearance certificate)
- (15) For Joint Venture/Partnership, Memorandum of Understanding (MoU) should be provided (CAC, Tax Clearance Certificate, Pension Compliance Certificate, ITF Compliance Certificate, NSITF Compliance Certificate, IRR& Sworn Affidavit are compulsory for each JV partner);
- (16) All documents for submission must be transmitted with a covering/forwarding letter under the Company/Firm letterhead bearing amongst others, the Registration Number (RC) as issued by corporate affairs commission (CAC), Contact Address, Telephone Number (GSM), and E-mail Address. The Letter Headed paper must bear the Names and Nationalities of the Directors of the company/firms at the bottom of the page and duly signed by the authorized officer of the company/firm and documents/information must be arranged and submitted in the sequence/order as listed above.
