(f) Evidence of registration on the National Database of Federal Contractors, Consultants, and service providers by submission of Interim Registration Report (IRR) expiring on 30th June, 2020 or valid Certificate issued by BPP.

(g) Sworn affidavit:

- disclosing whether or not any officer of the relevant committees of the Ignatius Ajuru University of Education or the Bureau of Public Procurement (BPP) is a former or present director or shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in this Old are true and correct in all
- That none of the Directors of the firm has been convicted of any criminal offence related to fraud, financial impropriety, falsification or act of similar nature.

(h) Verifiable company's Audited Account for the last three (3) years (2017, 2018, 2019).

(i) Evidence of financial capability to execute the project by submission of reference letter from a reputable Commercial bank indicating willingness to provide facility for the execution of the project when needed. (j) Company's profile with the curriculum vitae of Key staff to be deployed for the project, including copies of their academic/professional qualifications.

(k) Verifiable documentary evidence of at least three (3) similar Jobs executed, in the last five (5) years including letters of awards, valuation certificates, job completion certificates and photocopies of the projects.

(I) Evidence of qualification as a Qualified and Certified ICDL Expert/Trainer- copy of credential to be submitted.

(m) Evidence of accreditation issued by Centre for Management Development (CMD);

(n) Evidence of registration with Computer Professionals Registration Council of Nigeria and National Information Technology Development Agency (NITDA);
