(1) INTRODUCTION

The Federal University of Technology Owerri, in compliance with the requirement of the Public Procurement Act 2007, invites interested, competent Consultants with proven experience and good track record of performance to indicate interest in our Years 2016/2017/2018 (Merged) TETFund ICT SUPPORT Intervention listed below:

(2) SCOPE OF SERVICES

Lot 1	Website Upgrade, Design, Migration to conform to TETFund guidelines and ICT Staff Training;

(3) ELIGIBILITY REQUIREMENTS

To be eligible, potential companies are required to submit all the under listed verifiable documents and must be arranged in the following order and numbered:

(i) Evidence of Certificate of Incorporation (or Business Name where applicable) with the Corporate Affairs commission (CAC) including forms CAC2 and CAC7, or Business Name;

(ii) Evidence of Company's current Tax Clearance Certificate (or Personal Income Tax Clearance Certificate) for the three (3) years-2016, 2017 and 2018, expiring on 31st December, 2019 and with a minimum Annual Turnover of 3 million naira for each year;

(iii) Evidence of Current Pension Compliance Certificate valid till 31st December, 2019 (where applicable);

(iv) Evidence of Current Industrial Training Fund (ITF) Compliance Certificate valid till 31st December, 2019 (where applicable);

(v) Evidence of Current Nigeria Social Insurance Trust Fund (NSITF) compliance valid till 31st December, 2019;

(vi) Evidence of Registration on the National Database of Federal Contractors, Consultants and service Providers by submission of Interim Registration Report (IRR) expiring on 31/1/2020 or valid certificate issued by BPP;

(vii) A Sworn Affidavit:

- Disclosing whether or not any officers of the relevant committees of the Federal University
 of Technology Owerri or the Bureau of Public Procurement is a former or present Director,
 shareholders or has any pecuniary interest in the Company and to confirm that all
 information presented in its bid are true and correct in all particulars
- The director (s) of the company expressing interest, have never been convicted by any law court.
- The company is not bankrupt.

(viii) Company's Audited Accounts for the last three (3) years (2016,2017 and 2018), certified by a professional Accounting/Audit firm.

(ix) Company's Profile with the Curriculum Vitae (CV) of Key staff to be deployed for the project including copies of their Academic/ Professional Qualifications.

(x) Verifiable documentary evidence of at least three (3) similar jobs executed in the last five (5) years including letters of awards, job completion certificate showering timely completion of the projects and photograph of the projects. Evidence of 5 Years of Website Design experience including: HTML, CSS, JavaScript, Latest release of WordPress CMS (WP Engine, PHP, 3rd Party APIs Gravity Forms, Pods etc) or Latest release of Joomla CMS or Latest releases of Drupal CMS for LOT 1

(xi) Evidence of Firm's Accreditation by Computer Professionals Registration Council of Nigeria (CPN) and National Information Technology Development Agency (NITDA);

(xii) Evidence of Firm's Accreditation as a Test Centre, International Computer Driving Licence (ICDL) certificate.

(xiii) Evidence of at least 3 ICDL certified trainers with certificates

(xiv) Evidence of Firms registration with Centre for Management Development (CMD)

(xv) Evidence of financial capability to execute the project by submission of reference letters from a reputable commercial bank in Nigeria indicating willingness to provide credit facility for the execution of the project when needed.
