- Disclosing whether or not any officer of the relevant committees of Gombe State University or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars;
- That the Company is not bankrupt, in receivership or under liquidation or involved in any litigation which can potentially affects the Company's ability to effectively discharge her responsibilities (if engaged);
- That no Director of the Company has ever been convicted (or criminal offences relating to fraud or financial impropriety in any court of law

 - (j) Evidence of financial capability to execute the project by submission of Reference Letter from a reputable commercial bank in Nigeria; indicating willingness to provide credit facility for the execution of the project when needed;
 - (k) Company Profile with the Curriculum Vitae of Key Staff to be deployed for the project, including copies of their Academic/Professional qualifications e.g. ICDL Certificate;
 - (I) For Training: Evidence of Firm's registration with Centre for Management Development (CMD);
 - (m) Verifiable documentary evidence of at least three (3) similar jobs executed In the last five (5) years including Letters of Awards, Valuation Certificates, Job Completion Certificates and Photographs of the projects;

Telephone Number (preferably GSM No.), and e-mail address. The Letterhead Paper must bear the Names and Nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorised officer of the firm;

(o) A letter of authority empowering the university to verify any claims contained in the submitted documents;
