INVITATION FOR EXPRESSION OF INTEREST MINISTRY OF HEALTH

The State Ministry of Health (SMoH) on behalf of the Enugu State Government (the state) is calling for expression of interest from qualified contractors for the procurement of Basic Medical and Office Equipment vital for operationalization of the expanded facilities at the Poly Clinic Enugu and General Hospital Udi.

The Enugu State Ministry of Health hereby invites interested and qualified contractors to express interest in the following supplies:

(1)	Procurement of furniture for the two hospitals
(2)	Procurement of Hospital Equipment for one hospital

GENERAL REQUIREMENTS:

Interested contractors are required to provide the following documents:

- (1) Evidence of Certificate of incorporation with Corporate Affairs Commission (CAC).
- (2) Evidence of registration with Enugu State Government as a contractor/ consultant/ supplier.
- (3) Evidence of Registration and payment of Value Added Tax (VAT) (if cooperate entity).
- (4) Evidence of Company Tax Clearance Certificate for the last three (3) years (if cooperate entity).

- (5) Evidence of three (3) years unabridged company audited report certified by a Chartered Accountant/Auditor.
- (6) Evidence of execution of similar jobs in the recent past.
- (7) Evidence of payment of 2% Bid Security in a draft addressed to the government.
- (8) Evidence of financial capacity from a reputable financial institution.
- (9) Evidence of payment of non- refundable processing fee of N50,000 into , the Enugu State Government (IGR) Account
- (10) All expression of interest must be signed by an Officer authorized to bind the organization to a contract
- (11) Sworn affidavit disclosing that they do not have any Director who have been convicted for any criminal offence relating to fraud, financial impropriety, criminal misrepresentation or falsification of facts relating to any matter.
- (12) Verifiable registered business address.
- (13) Company profile with telephone numbers of key personnel.
- (14) Affidavit authenticating all documents submitted.
- (15) Enugu State Government is not under any obligation to engage any company who did not meet the requirement

Note: For the purpose of evaluation and comparison of bids that have been adjudged as valid, no other method or criteria shall be used except those stipulated in the solicitation documents.
