SCOPE OF WORK

- (1) Normal site supervision and related consultancy services.
- (2) Tendering process/analysis and report.

QUALIFICATION CRITERIA

- (e) Evidence of compliance with Pension Reform Act 2014 by registration with National Pension Commission (PENCOM)

- (f) Evidence of compliance with the provision of Industrial Training Fund (ITF) Amendment Act by registering with the fund.
- (g) Verifiable evidence of having successfully provided consultancy services of similar work in the past indicating the name of the clients and the projects, etc.
- (h) Evidence of financial capability and banking support to undertake the project.
- (i) Company profile with names and qualifications of key technical personnel to be used with photocopies of their certificates.
- (j) Any other relevant information that will be helpful in determining consultants suitability for the work.
