- (iii) Evidence of registration as Contractor with Oyo State Bureau of Public Procurement.
- (iv) Registration of Business Premises with Oyo State Ministry of Trade and Investment.
- (v) Evidence of two directors of the Company's Tax Clearance
- (vi) Evidence of payment of Government Development Levy.
- (vii) Evidence of previous contracts executed and completed with verification of completion for the last five years.
