- Renovation of College Hall
- Renovation of two (2) blocks of 2-Classrooms

LOT II – Government Technical College, Ibadan

- Renovation of one block of multi-purpose laboratory

LOT III – Government Technical College, Oyo

- Renovation of a block of 6-Classrooms
- Renovation of two (2) blocks of six (6)-Compartment Toilet each

LOT IV– Government Technical College, Ogbomosho

- Renovation of a block of Workshop

LOT V– Government Technical College, Iseyin

- Renovation of two (2) blocks of four (4) classrooms each

LOT VI – Government Technical College, Saki

- Renovation of a block of six (6) Classrooms

TENDER QUALIFICATION

Each tender should be accompanied by the following:

- (a) Evidence of Company's Certificate of Registration with Corporate Affairs Commission (CAC).
- (b) Evidence of Company's registration with Federal Inland Revenue Services (FIRS).
- (c) Evidence of Company's Registration with Oyo State Bureau of Public Procurement.
- (d) Evidence of verifiable previously executed jobs (Contractors with history of abandoned projects or poorly executed projects will not be considered).
- (e) Evidence of Registration Premises with Oyo State Government.
- (f) Tax Clearance Certificate of at least 2 Directors (Limited Liability Company) or the Proprietor/Partner (Enterprise) for the last three (3) years.
- (g) Evidence of payment of Tender Fee for each LOT.
- (h) A sworn affidavit in line with the provision of Part IV, Section 22 (6b, c, e & f) of the Oyo State Public Procurement Law 2010 stating that none of the persons connected with the bid process in the procuring entity or bureau has any pecuniary interest and that the company is not in receivership of any form of insolvency, bankrupt nor debarment and that the Company nor any of the directors) of the Company has been convicted of financial crimes.

TENDER MODALITIES

- Tendering shall be by open tendering.
- Tenderers should note that failure to include any of the required documents above renders the tender invalid for further consideration.
