(3) TENDER PRE-QUALIFICATION REQUIREMENTS

Each tender should be accompanied with the following:

(i) Evidence of Company's Certificate of Registration with the Corporate Affairs Commission (CAC)

(ii) Evidence of Company's Registration with Oyo State Bureau of Public Procurement, Governor's Office, Secretariat, Ibadan

(iii) Tax Clearance Certificate of at least 2 Directors (in case of Limited Liability Companies or the Proprietor/Partner (in case of Enterprise) for at least Three (3) years from 2017 valid till December, 2019.

(iv) Evidence of Registration of Business Premises with Oyo State Government.

- (v) Evidence of verifiable list of previous/similar projects executed with Letters of Commission and Certificate of Practical Completion.
- (vi) Evidence of financial capability/reference letter from a reputable Commercial Bank.
- (vii) A sworn affidavit disclosing;
 - (a) Whether or not any officer of the relevant Committees of Procurement entity or Bureau is a former or present Director, Shareholder, or has financial interest in the bidder and confirm that all information presented in the bid are true and correct in all particulars.
 - (b) that the Company is not in receivership of any form of insolvency, bankruptcy proceedings nor the subject of any form of winding up petition proceedings.
 - (c) That none or any of the Directors of the Company has been convicted in any country for financial crimes relating to fraud or financial impropriety or falsification of facts relating to any matter.
- (viii) Letter of consent to allow for verification of all the documents submitted.
