#### INTRODUCTION

- (e) Verifiable evidence of current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate valid till 31st December, 2019.
- (f) Evidence of registration on the National Database of Federal Contractors, Consultants, and service providers by submission of Interim Registration Report (IRR) that is currently valid.
- (g) Sworn affidavit disclosing whether or not any officer of the relevant committees of the Ignatius Ajuru University of Education or the Bureau of Public Procurement (BPP) is a former or present director or shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in this bid are true and correct in all particulars.
- (h) None of the Directors of the firm has been convicted of any criminal offence related to fraud, financial impropriety, falsification or act of similar nature and to state that all documents used for this bidding are genuine.
- (i) Verifiable company's Audited Account for the last three (3) years (2016, 2017, 2018).

- (j) Evidence of financial capability to execute the project including reference letter from a reputable commercial bank indicating willingness to provide facility for the execution of the project when needed.
- (k) Company profile with the curriculum vitae of key staff to be deployed for the project, including copies of their academic/professional qualifications.
- (I) Verifiable documentary evidence of at least three (3) similar jobs executed, in the last five (5) years including letters of awards, valuation certificates, job completion certificates and photocopies of the projects.
- (m) Evidence of qualification as a Qualified and Certified ICDL Expert/Trainer copy of credential to be submitted.
