**INVITATION FOR PRE-QUALIFICATION AND TENDER FOR RE-SCOPED YEARS 2015 AND 2016

PREAMBLE

- (f) Evidence of Technical Capability (CVs of relevant personnel)
- (g) Annual Turnover of not less than N70,000,000.00
- (h) Evidence of timely completion of similar projects executed (must include practical completion certificates)
- (i) A sworn affidavit disclosing whether or not any officer of the relevant committees of Federal Polytechnic Nekede, Owerri or the Bureau of public Procurement is a former or present director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars.
- (j) Evidence of current Industrial Training Fund (ITF) compliance Certificate (2018);
- (k) Evidence of Registration with National Pension Commission, in compliance with the provisions of Section 16(b)(d) of the public procurement Act 2007 (PPA2007) – (Must provide current PENCOM Certificate).
- (l) Evidence of current Nigeria Social Industrial Training Fund (NSITF) compliance Certificate (2018); and
- (m) Evidence of registration on the National Database of Contractors, Consultants and Service Providers by inclusion of Current Interim Registration Report (IRR) issued by Bureau of Public Procurement (BPP).
