  - (8) Evidence of Technical/Managerial Capabilities
  - (9) Evidence of compliance with NSITF act.
  - (10) Evidence or execution of previous similar project with SUBEB or any other similar organization in the State/Country.
  - (11) Evidence of Annual Turnover Company for at least 3 years.
  - (12) Evidence of Payment of Payee.
  - (13) Evidence of Registration with VAT office.
  - (14) Evidence of Payment of Tax Clearance for 3 years.
  - (15) Evidence of Local Resources Utilization with Communities responsibilities
  - (16) Sworn Affidavit from the High Court of Justice in the Country, Affirming that No officer of SUBEB or relevant committees of the Kano State Due Process Bureau or the BPP is a former Director or present shareholder, has any pecuniary interest in the bidder, that all information presented in the bid are true and correct in all particulars, that none of the directors has been committed in any Court of Law for any Criminal offence including fraud and any financial Impropriety falsification or act in similar nature and that all information contained in bidding are genuine
- (b) Late submission of pre-qualification documents will not be entertained please.

( c) Submitted pre-qualification documents will be opened by 12:00 pm on the closing date at the SUBEB SBMC Hall SUBEB Headquarters Audu Bako Secretariat Kano.
