- (b) Evidence of Company's document Tax Clearance Certificate for the last three (3) years (2017, 2018, and 2019) valid till 31st December, 2020;
- (c) Evidence of current Pension Compliance Certificate valid till 31st December, 2020;
- (d) Evidence of Industrial Training Fund Compliance Certificate valid till 31st December, 2020;
- (e) Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate valid till 31st December, 2020
- (f) Evidence of Registrar on the National Database of Federal Contractors, Consultant and Service Providers by submission of Interim Registration Report (IRR) expiring on 30/6/2020 or valid certificate issued by BPP.

- Disclosing whether or not any officer of relevant committee of the University of Ilorin Teaching Hospital or the Bureau of Public Procurement is a former or present director, shareholder, or has any pecuniary interest in the organization and confirm that all information presented are true and correct in all particulars;
- Company's Audited Accounts for the last three years (2017 and 2018, 2019) duly stamped licensed Auditors.
- Evidence of financial capability to execute the projects submission of Reference reputable commercial bank in Nigeria, indicating willingness to provide credit facility for the execution of the project when needed;
- Company's Profile with the Curriculum Vitae of Key Staff to be deployed for all project including copies and Academic/Professional qualifications; COREN, QSRBN, ARCON, CORBON etc;
- Verifiable documents evidence of at least three (3) similar jobs executed in the last five (5) years including Letters of Awards, Valuation Certificates and Photographs of the projects
- List of Plants/Equipment including proof of Ownership or Lease
- All documents for submission must be transmitted with a Covering/Forwarding letter under the Company Firm's Letter Head Paper bearing amongst others, the Registration Number (RC) as issued by the Corporate Affairs Commission (CAC), Contact Address, Telephone Number (preferably GSM No, and e-mail address. The Letterhead Paper must bear the Names and Nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorised officer of the firm.

(5.0) SUBMISSION OF TENDER DOCUMENTS

Prospective bidders are to submit bid for each of the LOT desired, two (2) here copies each at the technical and financial bids with soft copy of financial bids only in MS Excel format packaged separately in sealed and envelopes and clearly marked as "Technical Bid" or "Financial Bid".

Thereafter, put the two sealed envelopes together in a bigger sealed envelopes addressed to Chief Medical Director, University of Ilorin Teaching Hospital, Ilorin Kwara State and clearly marked with the name of the project and the LOT number" Furthermore, the reverse of each sealed envelope should bear the name and address of the bidder and dropped in the registered Tender Box at the office of the Head, Procurement Unit not less than **12:00 noon on Monday 6 July, 2020**
