### **INVITATION FOR PRE-QUALIFICATION AND TENDER FOR YEAR 2014, 2015, AND 2016 (MERGED) TETFUND NORMAL INTERVENTION PROJECTS.**

#### **(1) INTRODUCTION**

The Federal College of Education (Special), Oyo, Oyo State intends to execute Year, 2014, 2015, and 2016 (MERGED)TETFund normal intervention projects in the current fiscal year to enhance teaching and learning towards realization of the set goals. In view of the above, the College is inviting interested, competent and reputable contractors to tender for the projects described below.

#### **(2.0) PROJECTS TO BE EXECUTED**

**(A)** Lot 1: Construction of 1 – storey Science Complex, Comprise of Biology Laboratory, Physics Laboratory, Gymnasium for PHE and Administrative offices.

**(B)** Lot 2: Construction of 1- storey Science Complex, Comprise of Chemistry Laboratory, Mathematics Laboratory, HOD, Staff offices and Toilets.

**( C)** Lot 3: Construction of 1- storey Science Complex, Comprise of Integrated science Laboratory, Computer Science Laboratory, HOD, Staff offices and Toilets.

**(D)** Lot 4: Construction of External works to Science Complex which include Hard and soft Landscaping Drilling of motorise Borehole.

**( E)** Lot 5: Construction of 1 Storey Building comprises of Adult and Non – Formal Education.

**( F)** Lot 6: Construction of 2Storey Building comprises of Early Childhood Care Education Department and Deans Office.

**( G)** Lot 7: Construction of 1 Storey Building comprises of Primary Education Studies.

**( H)** Lot 8: Construction of Bindery Building including External work.

**( I)** Lot 9: Furnishing of Science Laboratory to Chemistry, Biology, Integrated and Physics Laboratory

(J) Lot 10: Renovation of Administrative Block Phase 1(ETF 2001 Project), College Clinic (1999ETFf Project), National Resource Centre for the Disabled (2002 ETF Project). School of Science Hall and Centre for Educational Technology.

(K) Lot 11: Supply and Installation of Classroom Furniture.

(L) Lot 12: Furnishing of School of Early Childhood Care. Primary and Non – formal Education,

(M) Lot 13: Furnishing of Computer Science Department, Bindery Unit, and School of Early Childhood, Primary. Adult and Non- formal Education.

### **(3.0) MANDATORY REQUIREMENTS FOR BIDDERS**

(a) Verifiable Certificate of Incorporation with Corporate Affairs Commission (CAC)

(b) Verifiable Evidence of Valid (FIRS) TAX clearance Certificate for the last three years (3) (2014, 2015, & 2016) corresponding to declared turnover.

(c) Verifiable Current Industrial Training Fund (ITF) Compliance Certificate.

(d) Verifiable Current PENCUM Compliance Certificate Issued by National Pension Commission.

(e) Verifiable Certificate of Interim Registration Report (IRR) with the Bureau of Public Procurement (BPP) showing registration on the National Data base of contractors, consultant and service providers.

(f) Verifiable Current NSITF Compliance Certificate)

(g) Current Company's audited account duly stamped and signed by ANAN/-ICAN Licensed Auditors for the last three years.

(h) Verifiable Office and Workshop address(es): NOT P. O. Box but should include telephone numbers of company directors).

(i) Verifiable list of executed similar jobs at least three (3) in the last five years (i.e. letters of awards and certificates of practical job completion etc.).

(j) Evidence of financial capability evidence of financial backing/Original reference letter from a reputable Bank.

(k) Original Bank Statement for the past twelve (12) months and documents demonstrating availability of fund/liquid assets and or credit facilities from banker(s) to successfully complete the contract.

(l) A comprehensive Company profile to include Verifiable at least three key personnel and their ID, with their Academic and professional certificates

(m) Evidences of ownership of lease agreement for relevant equipment machines, tools and workshop where necessary etc

(n) For joint venture (JVS), include the Memorandum of Understanding (MOU)

(o) A Sworn Affidavit disclosing whether or not any officer of Federal College of Education (Sp.), Oyo. Oyo State is a former or present director, shareholder or has any pecuniary interest in the bid and that all the information/documents provided in its bid are true and correct and that no director of the firm has been convicted by any court of law and the firm is not bankrupt or in receivership.

(p) Evidence of education tax remittance.

(q) Arrangement of the technical documents in hard and soft copies should follow the order in the list above and appropriately paged. The technical documents should have a table of content indicating the pages on which these items are to be found.

(r) Each page of financial Bid should be duly signed by the tenderer or else the bid will be rejected.

#### **4.0 COLLECTION OF BID/TENDER DOCUMENTS:**

Tender documents are to be collected from the office of the Head, Physical Planning of Procurement Department between the hours of 10:00a.m. – 4:00p.m. daily upon presentation of authenticated payment details of the non-refundable tender fee of N50,000.00 only obtained from an approved Bank by the College Bursar.

#### **5.0 SUBMISSIONS OF BID DOCUMENTS:**

Both the Technical and Financial documents should be neatly bound and each sealed in a separate envelope marked at the top and labeled Technical or Financial Bid respectively and both packed in a bigger envelope including Company's name, particular and name of the project, and should be dropped into the tender box at the Provost's office of the College. The bids will be opened at the New Council Chamber of Federal College of Education (Special), Oyo, Oyo State at the appropriate stipulated date above.

#### **PLEASE NOTE:**

- (i) Compliance certificates may be referred to the respective issuing authority for verification and authentication.
- (ii) Any Technical and Financial bids enclosed in a single envelope that is not sealed at time of opening shall be disqualified.
- (iii) Incorrect address or labeling of submitted bids shall be rejected.
- (iv) Each parcel should have a table of contents indicating the pages or folios in which these items are to be found

(v) This advertisement of invitation of tender shall not be construed as a commitment on the part of Federal College of Education (Special), Oyo, Oyo State nor shall it entitle any company to make any claim whatsoever or compensation having responded to this advertisement.

(vi) All expenses incurred in preparing pre-qualification documents associated with this exercise shall be borne solely by the prospective company.
