INVITATION FOR PRE-QUALIFICATION AND TENDER FOR YEAR 2018 CAPITAL PROJECTS AND YEAR 2017 TERTIARY EDUCATION TRUST FUND (TETFUND) ZONAL INTERVENTION PROJECT. FEDERAL COLLEGE OF EDUCATION (SPECIAL) OYO, OYO STATE

(1.0) INTRODUCTION

The Federal College of Education (Special), Oyo, Oyo State intends to execute Year 2018 Capital Projects in the current fiscal year and Year 2017 Tertiary Education Trust Fund Zonal Intervention to enhance teaching and learning towards realization of the set goals. In view of the above, the College is inviting interested, competent and reputable contractors to tender for the projects described below.

(2.0) PROJECTS TO BE EXECUTED UNDER YEAR 2018 CAPITAL PROJECTS:

- (a) Lot 1: Construction and Completion of Road and Drainages (On-going).
- (b) Lot 2: Construction and Completion of Resource and Training Workshop for Technical Education at School of Voc. and Tech (On-going).

(3.0) PROJECTS TO BE EXECUTED UNDER YEAR 2017 TETFUND ZONAL INTERVENTION:

- (a) Lot 3: Procurement and Installation of Thin Client Computers.
- (b) Lot 4: Procurement of Toyota Hiace Bus.

(4.0) MANDATORY REQUIREMENTS FOR BIDDERS

- (a) Verifiable Certificate of Incorporation with Corporate Affairs Commission (CAC)
- (b) Verifiable Evidence of Valid (FIRS) TAX clearance Certificate for the last three years (3) (2015, 2016, & 2017) corresponding to declared turnover.
- (c) Verifiable Current Industrial Training Fund (ITF) Compliance Certificate.
- (d) Verifiable Current PENCOM Compliance Certificate Issued by National Pension Commission.

- (e) Verifiable Current Certificate of Interim Registration Report (IRR) with the Bureau of Public Procurement (BPP) showing registration on the National Data base of contractors, consultant and service providers.
- (f) Verifiable Current NSITF Compliance Certificate.
- (g) Current Company's audited account duly stamped and signed by ANAN/ICAN Licensed Auditors for the last three years.
- (h) Verifiable Office and Workshop address but should include telephone numbers of company director(s).
- (i) Verifiable list of executed similar jobs at least three (3) in the last five years (i.e. letters of awards and certificates of practical job completion etc.).
- (j) Evidence of financial capability/evidence of financial backing/Original reference letter from a reputable Bank.
- (k) Original Bank Statement for the past twelve (12) months and documents demonstrating availability of fund/liquid assets and/or credit facilities from the banker(s) to successfully complete the contract.
- (l) A Comprehensive Company Profile of Contractor to include at least three key personnel and their staff ID, with their Academic and professional Certificate.
- (m) Evidence of ownership or lease agreement for relevant equipments, machines, tools and workshop where necessary etc.
- (n) For joint venture (JVS), include the Memorandum of Understanding (MOU).
- (o) A Sworn Affidavit disclosing whether or not any officer of Federal College of Education (Sp.), Oyo, Oyo State is a former or present director, shareholder or has any pecuniary interest in the bid and that all the information/documents provided in its bid are true and correct and that no director of the firm has been convicted by any court of law and the firm is not bankrupt or in receivership.
- (p) Arrangement of the technical documents in hard and soft copies should follow the order in the list above and appropriately paged. The technical documents should have a table of content indicating the pages on which these items are to be found.
- (q) Each page of the financial Bid should be duly signed by the tenderer or else the bid will be rejected.

(5.0) COLLECTION OF BID/TENDER DOCUMENTS:

Tender documents are to be collected from the office of the Head, Physical Planning Unit of Procurement Department between the hours of 10:00a.m. -4:00p.m daily upon presentation of authenticated payment details of the non-refundable tender fee of N10,000.00 paid to an approved Bank, with the payment slip converted to receipt at the office of the College Bursar.

(6.0) SUBMISSIONS OF BID DOCUMENTS:

Both the Technical and Financial documents should be neatly bound and each sealed in a separate envelope marked at the top and labeled Technical or Financial Bid respectively and both packed in a bigger envelope including Company's name, particular and name of the project, and should be dropped into the tender box at the Provost's office of the College.

(7.0) CLOSING DATE AND TIME OF BIDS

Submission of bid documents into the tamper proof bid box shall end **six (6) weeks from the date of this publication i.e. 12, November, 2018 at 12:00 noon.**

(8.0) VENUE AND TIME OF OPENING OF BIDS

The bids will be opened immediately following the deadline stipulated for the Submission of bids as stated above i.e. **12, November, 2018 at 12:00 noon.**

The bids will be opened at the New Council Chamber of Federal College of Education (Special), Oyo, Oyo State at the appropriate stipulated date above.

PLEASE NOTE:

- Compliance certificates may be referred to the respective issuing authority for verification and authentication.

- Any Technical and Financial bids enclosed in a single envelope that is not sealed at time of opening shall be disqualified.
- Incorrect address or labeling of submitted bids shall be rejected.
- Each parcel should have a table of contents indicating the pages or folios in which these items are to be found
- This advertisement of invitation of tender shall not be construed as a commitment on the part of Federal College of Education (Special), Oyo, Oyo State nor shall it entitle any company to make any claim whatsoever or compensation having responded to this advertisement.
