 - (i) Verifiable list of executed similar jobs at least three (3) in the last five years (i.e. letters of awards and certificates of practical job completion etc.)
 - (j) For Training services:

- Evidence of Firm's registration with relevant professional body(ies); and
- Evidence of registration with Centre for Management Development (CMD)
 - (k) Evidence of financial capability to execute the project by submission of Reference Letter from a reputable commercial bank in Nigeria, indicating willingness to provide credit facility for the execution of the project when needed.
 - (I) A Comprehensive Company Profile to include at least three key personnel and their staff ID, with their Academic and professional Certificates.
 - (m) Evidence of ownership or lease agreement for relevant equipment, machines, tools and workshop (where applicable);
 - (n) For Joint Venture Partnership, Memorandum of Understanding (MoU) should be provided (CAC, Tax Clearance Certificate, Pension Compliance Certificate, ITF Compliance Certificate, NSITF Compliance Certificate, IRR & Sworn Affidavit are compulsory for each JV partner)
 - (o) All documents for submission must be transmitted with a Covering/Forwarding letter under the Company's Firm's Letter Head Paper bearing amongst others, the Registration Number (RC) as issued by the Corporate Affairs Commission (CAC), Contact Address, Telephone Number (preferably GSM No.), and e-mail address. The Letter head Paper must bear the Names and Nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorised officer of the firm.

Arrangement of the technical documents in hard and soft copies should follow the order in the list above and appropriately paged. The technical documents should have a table of content indicating the pages on which these items are to be found.

The tenderer should duly sign each page of the financial Bid or else the bid will be rejected
