- Company's profile to include at least four (4) key personnel with their academic and professional certificates.
- Proof of financial capability from reputable commercial banks.

Bidders are to obtain tender documents from the project unit of the Ministry of Health, Ilorin between the hours of 8:00 am and 4:00 pm daily from the above date of this publication, upon the payment of non-refundable tender fee to Kwara Internal Revenue Services (KWIRS).

Both the technical and financial documents are to be in sealed envelopes clearly marked “TECHNICAL & FINANCIAL BID DOCUMENTS FOR LOT.....” at the left corner indicating the project and address to the office of; The Honourable Commissioner, Ministry of Health, Fate Road, Ilorin. Submission of bids shall close at **12:00 noon on 31 March, 2020, Two (2) weeks from date of publication.** Opening of bids submitted shall commence immediately at office of the permanent secretary.
