(1.0) PREAMBLE

(1.0) PRE-QUALIFICATION REQUIREMENTS

(i) Evidence of valid Registration and incorporation with the Corporate Affairs Commission

(ii) Evidence of last three (3) years valid Tax Clearance Certificate

(iii) Evidence of current Pension Compliance (PENCOM) Certificate

(iv) Evidence of current industrial Training Fund (ITF) Compliance Certificate

(v) Current interim Registration Report (IRR) or Certificate as evidence of Registration on the National Database of Contractors, Consultants and Service Providers maintained by the Bureau of Public Procurement.

(vi) Current Certificate of Compliance with the Nigeria Social Insurance Trust Fund (NSITF) Act.

(vii) Three (3) Years Audited Accounts whose turnovers must be same values as in Tax Clearance Certificate;

(viii) Detailed Company Profile including list of key Professionals and their CVs (which should include academic/professional qualifications and certificates), (as applicable);

(ix) Evidence of experience of similar job executed within the last three (3) years with verifiable Letters of Awards and Certificates of job completion;

(x) Bidders that do not have an average yearly turnover in the last three(3) years for Lot 1 – N250M, Lot 2 – N300M need not apply.

(xi) A Sworn Affidavit that no Partner/Director has been convicted in a Court of law to any Country for criminal offences relating to fraudulent or corrupt practices, or criminal misrepresentation or falsification of facts relating to any matter and that all required documents are both genuine and up-to-date;

(xii) A Sworn Affidavit disclosing whether or act any officer of the Moshood Abiola Polytechnic, TETFund or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidding, that the company is not in receivership, insolvent or bankrupt and to confirm that all information presented in its bid are true and correct in all particulars

(xiii) The letter head of evert' bidder must bear the registration number as issued by the CAC, contact telephone number(s), valid e-mail address and official company address(not P.O.Box).

(xiv) The arrangement of the Technical documents should follow the order in the above list, appropriately paged and duly signed on every page. The technical table should have a table of contents indicating the pages on which these items are to be found.

(2.0) FINANCIAL BID REQUIREMENT

(i) Evidence of financial capability/Bank, reference and readiness to instruct bank to supply financial information on the company as may be required;

(ii) The financial bid for Lot 1 and 2 must be accompanied with a Tender/Bid security of 2% of the bid price obtainable from banks/financial institution in line with the extant provisions of the Public Procurement Act, 2007.

(4.0) TENDER DOCUMENTS COLLECTION
