(1.0) INTRODUCTION

The University of Uyo Teaching Hospital (UUTH), Uyo, Akwa Ibom State, is desirous of utilizing its 2017 National Health Insurance Scheme (NHIS) Intervention Fund and pursuant to Section 25(2)(ii), Public Procurement Act 2007, hereby invites reputable and competent contractors and suppliers to tender for the under-listed approved projects:

(3.0) ELIGIBILITY CRITERIA

Prospective bidders are required to submit the following documents:

- (a) Certificate of Incorporation/Evidence of Registration with the Corporate Affairs Commission;
- (b) Evidence of Value Added Tax (VAT) registration and Company Tax Clearance Certificate for the last Three (3) years 2014 – 2016;
- (c) Current PENCOS clearance certificate in compliance with the Pension Reforms Act 2014;
- (d) Current Nigerian Social Insurance Trust Fund (NSITF) clearance certificate;
- (e) Current ITF certificate in compliance with the Industrial Training Fund (ITF) Amendment Act 2011:

- (f) Evidence of Company registration in the National Database of federal contractors, Consultants and service providers;
- (g) A sworn affidavit that:
 - (i) The Company is not in receivership, insolvent or bankrupt;
 - (ii) None of the Company's directors has been convicted by any Court in any country for any criminal offence relating to fraud, financial impropriety, criminal misrepresentation or falsification of facts relating to any matter;
 - (iii) No officer of University of Uyo Teaching Hospital (UUTH) is a serving or former shareholder, director or staff of the bidder; and
 - (iv) No officer of University of Uyo Teaching Hospital (UUTH) or the Bureau of Public Procurement (BPP) has any pecuniary interest in the bidder and
 - (v) A sworn affidavit that all information presented and attached herein is true and correct.

(4.0) TECHNICAL REQUIREMENT

- (a) Evidence of verifiable similar jobs executed in the last Three (3) years (by inclusion of Letters of Award and Completion Certificates);
- (b) Evidence of financial capability with bank statement.
- (c) Audited account for the last 3 years (2014 – 2016).
- (d) Company profile including names, Curriculum Vitae, evidence of technical and professional qualification of key personnel.
- (e) Evidence of equipment owned
- (f) Manufacturer's authorization for Medical Equipment.
