- (2) Evidence of Current Tax Clearance Certificate for the last Three (3) years (2014-2016) issued by Federal Inland Revenue Service (FIRS);
- (3) Evidence of Current Certificate of Compliance by the National Pension Commission (PENCOM).
- (4) Evidence of Current Certificate of Compliance by the Industrial Training Fund (ITF).
- (5) Evidence of Current Certificate of Compliance with the Nigerian Social Insurance Trust Fund (NSITF);
- (6) Evidence of Current Interim Registration Report (IRR) on the National Database of Contractors, Consultants and Service Providers) with Bureau of Public Procurement (BPP);
- (7) Sworn Affidavit Stating that:
 - (a) None of the DIRECTORS has been in RECEIVERSHIP or INSOLVENCY or BANKRUPTCY:

(b) No OFFICER of the Federal College of Education, Pankshin or BPP is a FORMER or PRESENT DIRECTOR OR SHAREHOLDER who has any pecuniary interest in the bidder:

(c) They don't have any DIRECTOR who has been convicted in any country for any CRIMINAL OFFENCE relating to fraud or Financial impropriety or criminal misrepresentation or falsification;

(d) Confirming that all information presented in its bid are TRUE AND CORRECT in all particulars.

(B) Other Requirements

(8) Evidence of Company's Audited Annual Report for the immediate past Three (3) years (2014 – 2016) from a professional:

(9) Detailed Company's profile with:

(a) Possession of experience as Contractor or supplier in at least Three (3) projects of similar nature and complexity applied for with VERITABLE LETTERS OF AWARD and job COMPLETION CERTIFICATES;

(b) Possess adequate key Officers/Professional Personnel with their CURRICULUM VITAE (CV) including photocopies of their relevant PROFESSIONAL/TECHNICAL CERTIFICATES AND QUALIFICATIONS:

(10) Evidence of financial capability to execute the project (BANK REFERENCE);

(11) Veritable evidence of OWNERSHIP/LEASE OF EQUIPMENT to be used for the execution of the project.

(2.0) SUBMISSION OF PRE-QUALIFICATION DOCUMENTS

Documents for pre-qualification shall be submitted in a sealed envelope and addressed to, The Ag. Head, Procurement Unit, Federal College of Education, Pankshin and marked "Year 2013/2014/2015/2016 (Merged) TETFund Annual Intervention Projects: Pre-qualification Document f or Lot W1: Construction of Offices for *School of Adult, Non-Formal and Special Education*" as the case may be, and dropped in the Tender Box at the Ag. Head, Procurement Unit Office, New Administrative Block, Federal College of Education, Pankshin on or before 12.00 noon on Wednesday 13th December, 2017 between working hours of 8.00am to 4.00pm week days.

(3.0) OPENING OF PRE-QUALIFICATION DOCUMENTS

Pre-qualification documents shall be publicly opened immediately after the closing time of the same day, Wednesday 13th December, 2017 in the presence of Bidders or their representatives, Professional Bodies, Non-Governmental Organizations (NGOs) and interested members of the public at the Boardroom of the College Administrative Block.

(4.0) GENERAL INFORMATION

Interested bidders and the general public are invited to note that:

(a) Contractors/Suppliers who have worked for the Federal College of Education, Pankshin and have any history of poor performance, abandonment or unnecessarily prolonged contract execution/extension need not apply as they will be automatically disqualified;

(b) Certificates may be referred to the respective issuing authority for online verification and authentication;

(c) All documents for submission MUST be transmitted with a COVERING/FORWARDING LETTER under the COMPANY'S LETTER HEAD PAPER bearing among others; the Registration Number (RC) as issued by the Corporate Affairs Commission (CAC), Contact Telephone Numbers, valid Email Address and Official Company Address;

(d) All pre-qualifications documents MUST be properly packaged in line with Paragraph 4.0 of the advertisement;

(e) Non-compliance with the CONDITIONS stated therein will lead to AUTOMATIC DISQUALIFICATION of the BIDDER from the bidding process;

(f) Late submission of documents will be rejected and returned unopened to the Companies/Contractors.

(g) Applications MUST be in ENGLISH LANGUAGE and state clearly the area and lot for which the Company seeks to be pre-qualified.
