- (3) Evidence of current Pension Compliance Certificate valid till 31st December, 2018;

- (4) Evidence of current Industrial Training Fund (ITF) Compliance Certificate valid till 31st December 2018;
- (5) Evidence of current Nigeria Social Insurance Trust Fund (NSFTF) Compliance Certificate valid till 31stDecember, 2018;
- (6) Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 1/1/2019 or valid Certificate issued by BPP;
- (7) A sworn Affidavit by a Director certifying that;
- (a) The Director(s) of the company seeking pre-qualification have never been convicted by any law court.
- (b) The company is not bankrupt
- (8) None of the officers of the relevant committees of the Federal Polytechnic Oko or Bureau of Public Procurement is a former or present Director, shareholders or has any pecuniary interest in the Company and to confirm that all to format ton presented in its bid are true and correct in all particulars;
- (8) Comprehensive company profile with the curriculum vitae of key staff indicating technical staff (Architects. Structural. Mechanical, Electrical Engineers and Quantity Surveyors) and Administrative Staff strength, stating Phone numbers, academic and professional qualifications, including photocopies of certificates and years of experience of key personnel and membership of professional bodies (ARGON, COREN, CORBON and QSRBN) respectively,
- (9) Company's Audited Accounts for the last three (3) years (2015, 2016 and 2017), certified by a professional Accounting, Audit firm.
- (10) Verifiable documentary evidence of at least three (3) similar jobs executed in the last five(5) years including Letters of Awards, Valuation Certificates, lob Completion Certificates(showing timely completion of the projects) and Photographs of the projects.
- (11) List of verifiable equipment in full working condition to he used for the project stating whether owned, hired or leased with proofs and stating present local ion of such equipment.
- (12) Evidence of financial capability to execute the projects including reference letters from a reputable commercial bank indicating willingness to provide credit facility for the execution of the project when needed.

(13) Company's registered address, functional contact address, GSM phone numbers) and e-mail address.

#### (D) SUBMISSION OP BIDS

Prospective Contractors are to submit their documents with a covering/forwarding letter under the company's letter head paper bearing amongst others, CAC registration number, contact address, GSM No and email address sealed and clearly marked in a sealed envelope 'Technical Bid for the specific LOT", Name, telephone Number and mailing address of the Bidding Entry should also be clearly stated on the reverse side of me envelope addressed to: The Registrar, Federal Polytechnic Oko, P.M.B 021, Aguata, Anambra State, and inserted into the Tenders Box kept in the office of the Director of Physical Planning at the mam Campus of the Federal polytechnic Oko, Anambra State not later than 12:00 noon on Monday, 30<sup>th</sup> July, 2018.
