- (iii) Certified true copy of Memorandum and Article of Association.
- (iv) Evidence of payment of tax for the last three (3) years as at when due (such evidence should reflect the value of the undertaken by the Company in the last three (3) years).
- (v) Certificate of Compliance issued by the National Pension Commission as evidence of fulfilling employers' obligation to employees with respect to pension.
- (vi) Evidence of payment of training contributions to ITF (Industrial Training Fund).
