Interested companies/firms should submit their application for expression of interest along with the following documents;

- (a) Evidence of incorporation/Registration with Corporate Affairs Commission (CAC).
- (b) Evidence of three (3) years updated Tax Clearance Certificate (2017, 2018, 2019)
- (c) Evidence of Value Added Tax (VAT) Certificate.
- (d) Evidence of registration as a contractor with Gombe State Government.
- (e) Evidence of registration as a contractor with Gombe SUBEB.
- (f) Bank Reference letter showing company/firm relationship with the bank within 6-months from the date of this advert and evidence of financial capability.
- (g) Company resume including details of key staff to be deployed for execution of contract, phone number(s) and E-mail address.

(h) Evidence of execution and experience of similar work(s) done by the contractor for the last five (3) years, stating contract sum and showing evidence of award, completion and handling over.

(i) List of equipments to be used for the projects.
