- (vi) Evidence of verifiable similar projects executed within the last three (3) years including certificates of practical completion
- (vii) Verifiable evidence of relevant equipment and Plants with their location (where they can be inspected) with proof of ownership, hire or lease agreement
- (viii) Evidence of settlement of payee and other withholding taxes due to Kano State
- (ix) Vat registration and evidence of past remittances
- (x) Local resources utilization
- (xi) Community and corporate social responsibility support would be an added advantage
