- (12) A sworn Affidavit indicating whether any officer of the Federal Polytechnic Nasarawa is a former or present Director, shareholder or has any pecuniary interest in the company.
- (13) No bidder Should bid for more than Two(2) lots.
- (14) List of plants/equipment with proof of Ownership/lease (where applicable)
- (15) All documents for Submission must be forwarded with a covering letter under the company/firm letter headed.
