This invitation for pre-qualification for tenders follows the release of Matching Grant for 1st, 2nd 3rd, & 4th Quarters 2019 Allocation of the UBE Intervention Fund for the development of Public Schools (Pre – Primary, Primary Schools and Junior Secondary Schools) for Infrastructures. In compliance with the policy of due process of the Federal Republic of Nigeria, the State Universal Basic Education Board, Sokoto wishes to invite Pre-Qualified Contractors who wishes to tender for the following projects.

 - (ix) Evidence of Registration with state BPP and PPP.
