#### (1.0) INTRODUCTION

### (2.0) PROJECT SCOPE:

The scope of the project includes the following:

- (i) Construction of Public Primary School across the State
- (ii) Renovation of existing Public School structures across the State
- (iii) Provision of water supply and toilet facilities in Pubic Primary Schools across the State
- (iv) Supply of 3- seater desk including ECCDE furniture to Public Primary/Schools across the State.

- (ii) Names, qualification and experience of key personnel and copies of their professional certificates
- (f) Documentary Evidence of previous/similar works done in the past 3 years showing:
- (i) Letter of award of contract
- (ii) Certificate of completion
- (g) A sworn affidavit indicating that
- (i) None of the Directors of the Company has been convicted in any court for any criminal offence including fraud and financial impropriety
- (ii) The Company is not in receivership, insolvent or bankrupt.
- (iii) No officer of EDO SUBEB is a former or present Director, shareholder or has any pecuniary interest in the company
- (H) Bank Reference or Statement of account for the last 12 months (Jan 2019 Dec 2019)
