(b) Evidence of Company Income's Tax Clearance Certificate for the last three (3) years valid till 31 December, 2018

(c) Evidence of current Pension Compliance Certificate Valid till 31 December 2018;

(d) Evidence of current Industrial Training Fund (ITF) Compliance Certificate valid till 31 December 2018

(e) Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate valid till 3I December, 2018;

(f) Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 1/1/2019 or valid Certificate issued by BPP.

(g) Sworn Affidavit disclosing whether or not any officer of the relevant committees of the Federal College of Agricultural Produce Technology or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars;

(h) Company's Audited Accounts for the last three (3) years – 2015, 2016, 2017;

(i) Evidence of financial capability to execute the project by submission of Reference Letter from a reputable commercial bank indicating willingness to provide credit facility for execution of the project when needed;

(j) Company profile with the curriculum vitae of Staff to be deployed for the project, including copies of their Academic/Professional qualifications (in case of construction: COREN, QSRBN, ARCON, CORBON etc.)

(k) Verifiable documentary evidence of at least three (3) similar jobs executed in the last five (5) years including Letters of Awards valuation Certificates, Job Completion Certificates and Photographs of the projects;

(I) List of Plants/Equipment with proof of Ownership/Lease (where applicable);

(m) Only companies included in the National Automotive Design and Development Council's approved list of local manufacturers of vehicles or their authorized representatives should bid for Lots 4 & 5;

(n) All documents for submission must be transmitted with a Covering/forwarding letter under the Company/Firm's Letter head paper bearing amongst others the Registration Number (RC) as issued by the Corporate Affairs Commission, contact address. Telephone number (Preferably GSM no) and e-mail address. The Letterhead Paper must bear the Names and Nationalities of the authorised officer of the firm.

Furthermore, the reverse of each sealed envelope should have the name and address of the bidder and dropped in the designated Tender box in the Registrar's office **not later than 12:00 noon on Wednesday, 3 October, 2018**
