- (i) Verifiable evidence of incorporation with Corporate Affairs Commission (CAC) with form C02 and C07 included.
- (ii) Verifiable Tax Clearance Certificate in the last three years (2015, 2016 and 2017)
- (iii) Verifiable PENCOM Certificate (2017) in compliance with the amended PENCOM Reform Act of 2004.
- (iv) Verifiable evidence of compliance with the provisions of Employee Compensation Act 2010 through Nigerian Social Insurance Trust Fund (NSITF) clearance certificate.
- (v) Verifiable evidence of current Industrial Training Fund (ITF) clearance Certificate (2018) in compliance with Industrial Training Fund (ITF) Act 2015.
- (vi) Verifiable evidence of Registration on the National Database of Contractors, and Suppliers by inclusion of Interim Registration Report (IRR) issued by the Bureau of Public Procurement (BPP) 2107.

(vii) Verifiable evidence of compliance with Financial Reporting Council of Nigeria (FRGN) Act, No.6 (2011).

(viii) Verifiable evidence of financial capacity with an average annual turnover of not less than N20Million in the last three years (2015, 2016 and 2017).

(ix) Company Profile and evidence of Technical Qualification of Key Personnel including registration with relevant Professional bodies.

(x) List and verifiable documentary evidence of at least three (3) similar jobs successful executed in the last five (5) years including letters of award and job completion certificate.

(xi) List and verifiable evidence of construction equipment with proof of ownership or lease agreement.

(xii) Current sworn affidavit disclosing:

(a) That the company is not in receiving, bankrupt or insolvent.

(b) That the company does not have any Director who has ever been convicted in any court of Law in Nigeria or any other country for criminal offence in relation to fraud or financial impropriety.

(c) Whether or not any officer of the Federal Polytechnic, Ede is a former or present Director, Shareholder or has any pecuniary interest in the bidder, and

(d) That all documents submitted are true and genuine in all particulars.

Completed Technical and Financial bids are to be packaged in two separate envelopes. Each labelled Technical or Financial. The two envelopes should be enclosed in a large envelope labelled "Technical and Financial Bids" and name indicated at the top right hand corner of the envelope with the company name written behind and addressed to the Registrar, Federal Polytechnic, Ede, Osun State.

The documents should be deposited in the Tender box at Jimi Bamigbose Administrative Building at the North Campus of the Polytechnic **not later than Six (6) weeks from the date of this advertisement.**

CLOSING DATE / OPENING

Submission of documents **closes 12 noon on 7 November, 2018.** Any bid received after the stated date and time shall be rejected. The submitted bids will be opened on the same day at the Jimi Gbamigbose Administrative Building at the North Campus of the Polytechnic.

- (ii) Technical and Financial bids enclosed in one and same single envelope that will expose the Technical and Financial bids at the time during opening shall disqualified.
