5. Evidence of current ITF certificate in compliance with the Industrial Training Fund 2005.
6. Evidence of registration with National Social Insurance Trust Fund (NSIF).
7. Verifiable evidence of financial capability within the last 3 years (2015, 2016 & 2017).
8. Current Sworn Affidavit disclosing:
  - That the company is not in receivership, insolvent or bankrupt.
  - That the company does not have any Director who has ever been convicted in any court in Nigeria or any other country for criminal offence in relation to fraudulent financial impropriety.
  - Whether or not any officer of the college is a former or present Director Shareholder or has any pecuniary interest in the bid.
  - That all documents submitted for the bidding are true and current particulars.
  - List and verifiable documentary evidences of at least two (2) similar jobs successfully executed within the last five (5) years including letters of awards and job completion certificates.
