- (iv) Evidence of Current Pension Clearance Certificate based on the PENCOM Reform Act, 2014.
- (v) Evidence of Current Nigeria Social Insurance Trust Fund (NSIT) clearance certificate.

- (vi) Evidence of compliance with Financial Reporting Council of Nigeria (FRCN) Act No. 6 (2011).
- (vii) Interim Registration Report (IRR) issued by the Bureau of Public Procurement (BPC) to confirm registration as a contractor on the National Database
- (viii) Verifiable Evidence of financial capability with an average annual turnover of not less than N20million in the last three years (2014, 2015 & 2016).
- (ix) Evidence of current ITF Certificate in compliance with Industrial Trust Fund (ITF) Act, 2005.
- (x) List and verifiable documentary evidence of at least three (3) similar jobs successfully executed within the last five (5) years including letters of awards
- (xi) List of key technical personnel indicating their roles, designation, qualification certificate and years of experience with the guarantee that a minimum of three (3) relevant registered professional shall be deployed on the project.
- (xii) List of verifiable evidence of construction equipment with proof of ownership or lease of agreement.
- (xiii) All Documents for submission must be transmitted with a Covering/Forwarding Letter under the Company Letter Headed paper bearing amongst others, the Registration Number (RC) as issued by Corporate Affairs Commission (CAC), Contact Telephone Numbers, valid e-mail address and official Company address.
- (xiv) The Letter Head Paper must bear the Name, Nationalities, E-mail Address, and the Telephone Number of the Director of the Company at the bottom of the page.
- (xv) Current sworn affidavit disclosing:
  - (a) That the company is not in receivership, insolvent or bankrupt

(c) Whether or not any; officer of Federal Ministry of Education/Federal Government College, Ilorin is a former or present Director, Shareholder or has an pecuniary interest in the bidder.

(d) That all document submitted for the bidding are true and correct.

Bids will be opened on the same day at the College Conference Room behind the Administrative Block, Federal Government College, Ilorin. Bidders/Company representatives and interested members of the public including relevant professional bodies, Civil Society and Non-Governmental Organization are hereby invited to witness the public opening of the technical bids

(i) Certificate may be referred to the respective issuing authority for verification and authentication by the College authority.

(ii) Contractors are not permitted to bid for more than one lot. Any bidder that violates these rules shall be disqualified and any successful bidders will be invited for the next stage of the bidding process.

(iii) Technical and Financial bids enclosed in one and same single envelope that will expose the Technical and Financial bids at the same time of opening shall be disqualified.

- (iv) Submission that does not meet up with the requirement specifications above shall be rejected.
