**PROSPECTIVE BIDDER MUST POSSESS THE UNDER LISTED REQUIREMENTS:**

- (A) Evidence of Certificate of Incorporation with the corporation Affairs Commission (CAC) including Form CAC2 and CAC7;
- (B) Evidence of Company Income's Tax Clearance Certificate for the last three (3) years (2015, 2016 & 2017) valid till 31 December 2018.
- (C) Evidence of current pension compliance certificate valid till 31 December 2018.

(D) Evidence of Current Industrial Training fund (ITF) compliance Certificate valid till 31 December 2018.

(E) Evidence of current Nigeria social insurance trust Fund (NSITF) Compliance certificate valid till 31 December 2018

(F) Evidence of Registration on the National Database of Federal Constructors, Consultants and service providers by submission of interim Registration report (IRR) expiring on 1/1/2019 or valid certificate issued by BPP.

(G) Current sworn Affidavit disclosing:

(a) That the company is not in receivable, insolvent or Bankrupt

(b) That the company does not have any Director who has ever been convicted In any court in Nigeria or any other country for criminal offences in relation to fraud or financial impropriety.

(c) Whether or not any officer of the Federal Ministry of Education or Federal Government College Rubochi or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder; and

(d) That all documents submitted are true and correct in all particulars.

(H) Company's Audited Accounts for the last three (3) years (2015, 2016 & 2017)

(I) Evidence of financial capability to execute the project including -Reference letter from a reputable commercial Bank indicating willingness to provide credit facility for the execution of the project when needed.

(J) Company profile with the curriculum vitae of key staff to be deployed for the project, including copies of their Academic professional qualifications (in case of construction: COREN, QSRBN, ARCON, CORBON etc.).

(K) Verifiable documentary evidence of at least three (3) similar Jobs- executed In the last five (5) years Including letters of awards, valuation certificates, Job completion certificates and photographs of the projects.

(L) For Motor Vehicle's procurement: "only companies included In the National Automotive Design and Development Council's approved list of local manufacturers of vehicles or their authorized representatives should bid for the procurement;

(M) List of plants/Equipment with proof of ownership/lease (where applicable)

(N) For joint Venture/Partnership, Memorandum of understanding (MOU) should be provided (all the eligibility requirements are compulsory for each JV partner)

(O) All documents for submission must be transmitted with a covering/forwarding letter under the company/ Forms letter Headed paper bearing amongst others the registration Number (RC) as issued by the Corporate Affairs Commission (CAC), contact Address, Telephone Number (preferable GSM NO) and e-mail address. The letter head paper must bear the Names and Nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorized officer of the form.

#### **(4) COLLECTION OF TENDER DOCUMENTS**

Interested Companies are to collect the slandered Bidding Document (SBD) from the office of the principal Federal Government College Rubochi – Abuja an evidence of payment of a nonrefundable fee of N10,000.00 per lot, paid into the Federal Government College Rubochi's Remita account in any commercial Bank.

#### **(5) SUBMISSION OF TENDER DOCUMENTS**

Prospective bidders are to submit bid for each of the lot desired, two (2) hard copies each of the technical and financial bids with softcopy of financial bid only in MS excel format, packaged separately in sealed envelopes and clearly marked as a "Technical Bid" or "Financial Bid" thereafter, put the two sealed envelopes together in a bigger sealed envelope addressed to The Principal, FGC Rubochi – Abuja. Furthermore, the reverse of each sealed envelope should have the name and address of the bidder and drop in the designated Tender Box In principal's Office **not later than Monday 15 October, 2018 at 12.00noon.**

#### **(6) OPENING OF BIDS.**

The 'technical bids will be opened immediately after the deadline for submission **on, Monday 15 October, 2018 at 12:00noon** In the conference Room, Federal Government College Rubochi Abuja in the presence of bidders or their representatives. Please ensure that you sign the Bid Submission Register in the Office of the Principal Federal Government College Rubochi) as the College will not be held liable for misplace or wrongly submitted bids.
