Prospective Bidders must possess the under-listed requirements:

(i) Certificate of incorporation with Corporate Affairs commission

(CAC) including form CACQ2 and CAC07,

- (ii) Evidence of Company's current Tax Clearance Certificate for the last those (3) years (2015, 2016 and 2057) valid hi 31 December, 2018;
- (iii) Evidence of Current PENCOM compliance Certificate valid till 31 December, 2018;
- (iv) Evidence of Current Nigeria Social Insurance Trust Fund (NSITF) compliance certificate valid till 31December, 2018;
- (v) Evidence of current ITF compliance Certificate in line with Industrial Trust Fund (ITF) Act, 2005 valid till 31 December, 2018;
- (vi) Evidence of registration in the National Database of Contractors, Consultants and Service Providers by inclusion of interim Registration Report (SRR) issued by BPP valid till 1st January. 2019
- (vii) Audited account for the last three years (2015, 2016 & 2017) with verifiable evidence of financial capability with an average annual turnover of not less than N20million corresponding with the Tax Clearance Certificate;
- (viii) List and verifiable documentary evidence of at least three (3) similar jobs successfully executed within the last five (5) years including letters of awards and job completed certificates
- (ix) List of key technical personnel indicating their roles, qualification certificate and years of experience with the guarantee that a minimum of three (3) relevant registered professional shall be deployed on the project.
- (x) List of verifiable evidence of construction equipment with proof of ownership or tease of agreement.
- (xi) All Document for submission must be transmitted with a covering/Fowarding Letter under the Company Letter Headed paper bearing amongst others, the Registration Number (RC) as issued by Corporate Affairs Commission (CAC), Contact Telephone Numbers, valid e-mail address and official Company address.
- (xii) The Letter Head Paper must bear the Name, Nationalities, E-mail Address, and the Telephone Number of the Directors of the Company at the bottom of the page,
- (xiii) Current sworn affidavit disclosing:
 - (a) That the company is not in receivership, insolvent or bankrupt,
 - (b) That the company does not have any Director who has ever being convicted in any court in Nigeria or any other country for criminal offence In relation to fraud or financial impropriety.

(c) Whether or not any officer of Federal Ministry of Education/Federal Government College, Ilorin is a former or present Director, Shareholder or has an pecuniary interest in the bidder.

(d) That all document submitted for the bidding are true and correct.

(i) Interested and Competent bidders are requested to collect bid documents from the address below, upon presentation of evidence of payment through FGC Ilorin TSA Remita Platform of non-refundable tender fee of N10,000.00 Completed Technical and financial bids In separate envelopes (two sets of hand copies) shall be submitted The two envelopes should be labeled "Technical & Financial Bids" with the Project name at the top right corner with company name behind and enclosed in a larger third envelope addressed to: The Principal, Federal Government College, Ilorin, Kwara State.

(ii) The documents should be deposited in the Tender Box at the Vice Principal (Special Duties) office. Administrative Block, Federal Government College, Ilorin.

(5) CLOSING DATE AND OPENING

Submission of bid documents closes on or before **17 September, 2018 at 12.00pm** and late submission shall not be considered. Bids will be opened immediately following the deadline for the submission of bids on **17 September, 2018 at 12.00pm** at the College Conference Room behind the Administrative Block, Federal Government College, Ilorin. Bidders/Company representatives and interested members of the public including relevant professional bodies, Civil Society and Non-Governmental Organization are hereby invited to witness the public opening of the technical bids.

(i) Certificate may be referred to the respective issuing authority for verification and authentication by the College authority, (ii) Contractors are not permitted to bid for more than one lot Any bidder that violates these rules shall be disqualified and any successful bidders will be invited for the next stage of the bidding process.

(iii) Technical and financial bids enclosed in one and the same single envelope that will expose the financial bids at the same time of opening shall be disqualified,

(iv) Submission that does not meet up with the requirement specifications above shall be rejected.

(v) The Evaluation shall be strictly based on the requirement specified above.

(vi) This advertisement is published for information purpose, and will not be construed as a commitment or obligation on the part of Federal Government College, Ilorin to award these contracts.
