(iv) Current Industrial Training Fund (ITF) clearance certificate (2017) in compliance with Industrial Training Fund (ITF) Act, 2005;

(v) Registration with the Bureau of Public Procurement (BPP) Federal Contractors, Consultants and Suppliers Database in form of Interim Registration Report (IRR);

(vi) Verifiable evidence of Bank reference letter from a reputable Bank;

(b) That the company does not have any director who has ever been convicted in any court in Nigeria or any other country for criminal offence in relation to fraud or financial impropriety,

(c ) Whether or not any officer of the Federal Ministry of Education is a former or present Director, Shareholder or has a pecuniary interest in the bidder, and

(d) That all documents submitted are true and correct in all particulars.

(xv) All documents for submission must be transmitted with a covering/forwarding Letter under the Company's Letter Head paper bearing amongst others, the Registration Number

(RC) as issued by the Corporate Affairs Commission (CAC), contact Telephone Number, valid e-mail address and Company's address.

(xvi) The Letter Head Paper must bear the Name, Nationalities and the telephone Numbers, vof Directors of the Company at the bottom of the page;

(xvii) Verifiable evidence of payment of a non-refundable tender fee of N20, 000.00 to be paid to the School's Remitta platform.

Completed Technical and Financial bids in separate envelopes (two sets of hard copies) shall be submitted. Submission of documents doses **12 Noon on 11<sup>th</sup> September, 2017**. Any bid received after the stated date and time shall not be considered. The submitted bids will be opened on the same day 11<sup>th</sup>September, 2017 at Schools Conference Hall, Federal Science and Technical College, Zuru, Kebbi State. Bidders/Company representative and interested members of the public including relevant professional bodies, Civil Society and Non-Government Organizations are hereby invited to witness the opening of the technical bids.

**(6) PLEASE NOTE THAT:**

(i) A post review of Procurement Documentation may be carried out where Contractors and Service Providers may be required to present the original copies of their CAC, PENCOR, TAX, ITF Certificates and may thereafter refer any/all to the relevant Security Agencies, Corporate Affairs Commission, Federal Inland Revenue Services (FIRS), National Pension Commission and other relevant bodies for verification.

- (ii) Contractors are not permitted to bid for more than two lots. Any bidder that violates this shall be disqualified.
- (iii) Technical and Financial bids enclosed in one and same single envelope that will expose the Technical and Financial bids at the same time of opening shall be disqualified;
