(ix) Evidence of registration on the National database of Federal contractors, consultants and service providers by inclusion of interim registration report (IRR) expiring on 31/01/2020 or valid certificate issued by the Bureau of Public Procurement (BPP).

(x) Current Sworn Affidavit Certifying that:

(a) The company is not in receivership, insolvent or bankrupt.

(b) None of the directors has been convicted in any court of law or any criminal offence.

(c) No officer of the Ondo State university of Science and Technology Okitipupa or the Bureau of Public Procurement is a former or present director, shareholder or has any peculiar interest in the company and that all information presented in the document are true and correct in all particular.

(xi) For Joint Venture/Partnership, Memorandum of Understanding (MoU) should be provided (CAC, Tax Clearance Certificate, Pension Compliance Certificate, ITF Compliance Certificate, NSITF Compliance Certificate, IRR & Sworn Affidavit are compulsory for each JV partner).
