(3.0) ELIGIBILITY REQUIREMENTS

- (a) Evidence of Certificate of Incorporation with the Corporate Affairs Commission (CAC) including Form CAC2 and CAC7;
- (b) Evidence of company income's Tax Clearance Certificate for the last three (3) years valid till 31st December, 2019.
- (c) Evidence of current Pension Compliance Certificate (PENCOM) valid till 31st December, 2019;
- (d) Company's Audited Accounts for the last three (3) Years; 2016, 2017 and 2018;
- (e) Evidence of current Industrial Training Fund (ITF) Compliance Certificate, valid till 31st December, (2019);
- (f) Evidence of Current Nigeria Social Insurance Trust Fund (NSITF) compliance Certificate valid till 31st December, 2019;
- (g) Evidence of Registration on the National Database of Federal Contractors. Consultant and Services Providers by submission of Interim Registration Report (IRR) expiring on 31st January, 2020 or valid Certificate issued by (BPP);
- (h) Sworn Affidavit disclosing whether or not any officer of the relevant committees of the Kashim Ibrahim College of Education, Maiduguri or the Bureau of Public Procurement (BPP) is a former or present Director, Shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars.
- (i) Evidence of financial capability to execute the project including Reference Letter from a reputable Commercial bank indicating willingness to provide credit facility for the execution of the project when needed.
- (j) Company Profile with the Curriculum Vitae (CV) of key staff to be deployed for the project, including copies of their Academic/Professional qualifications, Registration with relevant Bodies.
- (k) Verifiable documentary evidence of at least three (3) similar jobs in the last five (5) years including letters of Awards Valuation Certificates, job Completion Certificates and photograph of the projects;

(l) For Joint Venture/Partnership, Memorandum of Understanding (MoU) should be provided (CAC, Tax Clearance Certificate, Pension Compliance Certificate, ITF Compliance Certificate, NSITF Compliance Certificate, IRR & Sworn Affidavit are compulsory for each JV Partners).

(m) Evidence of Accreditation by computer professionals of Nigeria, NITDA and Centre for Management Development, the computer training is to be facilitated by a qualified and certified ICDL Expert Trainer.
