(I) List of Plant/Equipment with proof of ownership/lease (where applicable)

(m) For Training/Empowerment programmes: evidence of Firm's registration with Centre for Management Development (CMD); n. All documents for submission must be transmitted with a Covering/Forwarding

(n) Letter under Company/firms Letter headed paper bearing Registration Number (RC), Contact Address, Telephone Number, e-mail address and names and Nationalities of the Directors.
