INTRODUCTION

Federal College of Education (Technical) Bichi is a Tertiary Institution Established by Decree No 4 of 14th March 1986, and reviewed by Decree No 3 of January 1993 by Federal Government of Nigeria with the sole aim of producing specialist Teachers in Technical, Vocational, Business and Science for the 6-3-3-4 system of Education.

In compliance with the Public Procurement Act 2007 as regards Procurement of Goods Works and services, Federal College of Education (Technical) Bichi invite interested and competent Contractors, Suppliers for the Constructions and Procurement of the following under listed Projects

CATEGORY A.

- (2) Construction of 4no 260 Seater Capacity Auditorium and Offices with External works
- (3) Construction of 500 Seater Capacity lecture Theatre and Offices with External works
- (4) Procurement and installation of office Furniture

CATEGORY B.

YEAR 2020 CAPITAL APPROPRIATION

- (1) Construction of Administrative Block & Building

ELIGIBILITY REQUIREMENTS

Prospective bidder must possess the under listed requirement to be eligible for the projects.

- (a) Evidence of certificate of incorporation with (CAC) including form CAC 2 and CAC7.
- (b) Evidence of Company income's Tax Clearance for 2018, 2019 valid till 31st December, 2020
- (c) Evidence of current Pension Compliance Certificate valid till 31st December, 2020
- (d) Evidence of current industrial Training Fund (ITF) Compliance Certificate valid till 31st December, 2020.
- (e) Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate valid till 31st December, 2020
- (f) Evidence of Registration on the National Database of Federal Contractors Consultants and Services Provider of Interim Registration Report (IIR) expiring on 30/6/2020 or valid Certificate issued by BPP
- (g) Sworn Affidavit:

- That the Director(s) of the firm has never been convicted by any court of law within and outside Nigeria.
- None of the company's Director or the Company itself bankrupt or in receivership;
- Disclosing whether or not any officer of the relevant committees of Federal College of Education (Technical) Bichi or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all Information presented in the bid are true and correct in all particulars.

- (h) Company Audited Account for the last three (3) years 2017, 2018, 2019
- (i) Evidence of financial capability to execute the project by submission of reference letter from a reputable commercial bank in Nigeria, indicating willingness to provide credit facility when needed;
- (j) Company Profile with Curriculum Vitae of key staff to be deployed for the projects including copies of Academic/Professional qualification such as COREN, QSRBN, ARCON, CORBON etc.

(k) Verifiable evidence of at least three (3) similar jobs executed in the last five (5) years including Letter of Awards, Valuation Certificate, job Completion Certificate and photographs of the projects.

(l) List of Plant/Equipment with proof of ownership/Lease

(m) All documents for submission must be transmitted with a Covering/ Forwarding letter under Company/ firms' letter Headed paper bearing Registration Number (RC), Contact Address, Telephone Number, e-mail address and Names and Nationalities of the Directors.

SUBMISSION OF PRE-QUALIFICATION DOCUMENTS

The pre-qualification document must be submitted in a seal envelope marked at the top left hand corner "Pre-qualification document stating the job the company applying for and forwarding to the Provost; Federal College of Education (Technical) Bichi P.M.B. 3473, Kano, not later than **12:00 noon Monday, 16 March, 2020**

OPENING OF BIDS DOCUMENTS

Bids document will be opened immediately after the deadline for submission at **12:00noon on Monday, 16 March, 2020** in the College Council chamber.

NOTE:

Only Companies whose Technical bids meet the stipulated minimum requirement would be contacted for collection of financial bid documents.

The minimum turnover is N100 million for category 'B' and bidder should not bid for more than 2 lots in Category 'A'

All enquiries (Not submission) should be directed to Director Procurement.

Late submission will be returned un-opened.

The College is not bound to pre-qualify any bidder and reserves the right to annul the Procurement process at any time without incurring any liabilities in accordance with Section 28 of the Public Procurement Act 20007
