(1) INTRODUCTION

The Ahmadu Bello University Teaching Hospital invites interested and reputable companies/contractors with requisite experience and competence to submit Technical Bid Qualification documents in respect of the 2020 capital projects execution in the Hospital.

(2) SCOPE OF WORKS

LOT 1: Procurement of Utility Vehicles (3 Salon Cars)

(3) ELIGIBILITY REQUIREMENTS:

Interested companies are required to submit the following documents:

(i) Verifiable Evidence of Incorporation and registration with Corporate Affairs Commission including form CAC2 and CAC&

(ii) Verifiable Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers of Interim Registration Report (IRR) or valid Certificate issued by BPP.

(iii) Evidence of Company Income's Tax clearance Certificate for the last 3 years valid till 31st December, 2020 (2017, 2018 & 2019)

(iv) Company's Audited Account for the last 3 years (2017, 2018 & 2019)

(v) Evidence of current Pension compliance certificate valid till 31st December 2020 where applicable.

(vi) Evidence of current Industrial Fund (ITF) compliance Certificate valid till 31st December 2020.

(vii) Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate Valid till 31st December, 2020

(viii) Every submission must be accompanied with a sworn affidavit disclosing whether or not any officer of the relevant committee of the ABUTH or the Bureau of Public Procurement is a former or present Director, Shareholder or has any pecuniary interest in the bidder and to confirm that all information and documents submitted are true and correct.

(ix) Verifiable documentary evidence of at least three (3) similar jobs executed in the last five (5) years including Letters of Award, Valuation Certificates, Job Completion Certificates and photographs.

(x) Company profile with the Curriculum Vitae of key staff to be deployed for the project including copies of their Academic/Professional qualifications.

(xi) All documents for submission must be transmitted with a covering/forwarding letter under the Company/Firm's Letter Headed Paper bearing amongst others, the registration Number (RC) as issued by the Corporate Affairs Commission (CAC), Contact Address, Telephone Number and e-mail address. The letter headed paper must bear the Names and Nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorized officer of the Company/Firm.

(4) SELECTIVE CRITERIA

In addition to the above, bidders should also submit the following:

(i) Evidence of Financial capability to execute the project including Reference Letter from a reputable commercial bank indicating willingness to provide credit facility for the execution of the project when needed.

(5) SUBMISSION OF PRE-QUALIFICATION DOCUMENTS

Prospective bidders are to submit Technical Bid documents for the supply: one (1) hard copies packaged in sealed envelopes and clearly marked as "Technical Bid'. Please indicate the Lot Number and project title at the right hand corner of the envelope an indicating bidders name and address on the reverse side and addressed to: The Chief Medical Director, Ahmadu Bello University Teaching Hospital Permanent Site, Shika Zaria.

The Tender document should be hand-dropped in the Tenders Box situated at the office of the Medical Director, ABUTH Zaria, not later than 3 Weeks from the date of this publication i.e. on or before **1:00pm Thursday, September 3, 2020.**

(6) OPENING OF TENDER DOCUMENTS

The Technical bids will be opened immediately after the deadline for submission i.e 1:00pm or Thursday, September 3, 2020 at the Board room of Ahmadu Bello University Teaching Hospital, Shika Zaria in the presence of bidders or their representatives.
