(vii) Sworn Affidavit disclosing whether or not any officer of the relevant committees of the Federal Polytechnic Mubi or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bids are true and correct in all particulars and that no Director of the company has been convicted in any country for any criminal offences relating to fraud or financial impropriety.
