- (e) Evidence of current Nigeria Social Insurance Trust fund (NSITF) compliance Certificate valid till 31 December, 2019.
- (f) Evidence of Registration on the National Database of Federal Contractors, Consultants and Service providers by submission of Interim Registration Report (IRR) expiring on 31/1/2020 or valid Certificate,

- (g) Sworn Affidavit disclosing whether or not any officer of the relevant committees of The Federal Ministry of Education Hqtrs or The Bureau of public procurement is a former or present Director, shareholder or has any pecuniary Interest In the bidder and to confirm that all Information presented in the bid are true and correct In all particulars;
- (h) Company's Audited Accounts For the last three (3) years – (2016, 2017, 2018),
- (i) Evidence of financial capability to execute the project by submission at reference letter from a reputable commercial bank in Nigeria indicating willingness to provide credit facility for the execution of the project when needed;
- (j) Company Profile with the Curriculum Vitae of Key Staff to be deployed for the project, including copies of their Academic / Professional qualification for Works,
- (k) Verifiable documentary evidence of a least three (3) similar Jobs executed in the last five (5) years including Letter of Awards, Valuation Certificates. Job Completion Certificates and Photographs of the projects;
- (l) List of Equipment With proof of ownership / Lease (for works);
- (m) For joint Venture/Partnership Memorandum of Understanding (MoU) should be provided (CAC, Tax Clearance Certificate, Pension Compliance Certificates, job Completion Certificates and ITF Compliance Certificate, NSITF Compliance Certificate, IRR & Sworn Affidavit) are compulsory for each JV, partner;
- (n) Only companies included in the National Automotive Design and Development Council's approved list of local manufacturers of vehicles or their authorized representatives should bid for the procurement of Utility Vehicle; and
- (o) All documents for submission must be transmitted with a Covering / Forwarding letter under the Company / Firm's Letter Head Paper bearing amongst others, the Registration Number IRC) as issued by the Corporate Affairs Commission (CAC), Contact Address, Telephone Number (preferably GSM No, and e-mail address, The Letterhead Paper must bear the Names and Nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorised officer of the firm.
