- Company Profile with Firm's Professional Registration, Curriculum Vitae of Key Staff and copies of their Professional qualifications;
- Verifiable documentary evidence of at least three (3) similar jobs in the last five (5) years including Letter of Awards, valuation Certificates and Job Completion Certificates;
- Sworn Affidavit disclosing whether or not any officer of the relevant committees of Technology Incubation Centre, Enugu or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars
