- (e) Evidence of financial capability to execute the job, including reference letter from a reputable commercial bank with willingness to provide credit facility for the execution of the project when needed.

The submitted technical bids shall be opened immediately following the deadline for the submission of bids **Monday 15 October 2018 at 12.00noon** at the Federal Government College, Idoani. Bidder's company representative and interested member of the public, including relevant professional organizations are hereby invited to witness the process of the technical bid.
