- (j) Evidence of issuance of Compliance Certificate to all Organizations by PENCQM in line with Pension Reform Act 2004 (as amended);
- (k) Evidence of compliance with the amended industrial training fund act. 2011;
- (l) Evidence of compliance with relevant provision of the NSITF Act
- (m) Submission of an interim Registration Report (IRR) as evidence of registration on the National Database of Contractors, Consultants, and Service Providers in line with Section 5(h) and 6(l) (f) of the PublicProcurementAct.2007.
